Thank you, members of the Moyaone, for your past financial support of our community. Invoices for the 2018 annual dues have been e-mailed. If you have not received yours, please contact me ASAP.

The consolidated fee for 2018 has increased to \$770 (the unimproved lot fee is unchanged). After much discussion, this change was approved by unanimous vote at the December budget meeting. The purpose of this increase is to counteract the effect of inflation, which had whittled down the buying power of the dues that were set some nine years ago. It will also put us in a position to resume contributions to our investment fund next year.

# The "Gateway to the Moyaone" Is a Dangerous Intersection

#### -Please Use Caution and Common Sense

Many residents of the Moyaone know me and Kirsten Watts. Kirsten grew up in the Moyaone on Overlook Drive, and I moved to Accokeek in the spring of 1995. We live at the intersection of Bryan Point Road and Farmington Road West.

When Kirsten Watts moved into our house in 1994, realtor Dottie Odell called this intersection the "Gateway to the Moyaone." In some ways it's a fitting description.

Since then, there have been a lot of changes in the area. There are more people living in the greater Accokeek region, and consequently there is much more traffic. Technology has also allowed for more distracted drivers.

There have been four traffic accidents at this intersection since last October, and many more over the past few years. It's hard to put a number on the close calls we've witnessed. At least six accidents have involved Moyaone residents.

I suspect that many local residents do not fully appreciate the change in the traffic dynamic of this intersection. Both roads that make up this intersection are posted at 30 mph, and there are STOP signs on each side of Farmington Road West. Many people routinely pass through the intersection at much higher speeds, and often fail to stop at the sign.

This makes for a dangerous situation, especially when coupled with the physical features of the intersection.

Consider the following:

- It is not a perfectly perpendicular intersection, i.e., the roads do not intersect at 90° angles.
- As you approach Farmington Road West departing the Moyaone, there are slight bends in the road before and after the intersection. There is also a sharp bend in Farmington Road West as you approach the intersection from the Christ Church side.
- There is vegetation on both sides of Bryan Point Road that
  obstructs the view of oncoming cars when you are at the
  STOP sign wanting to turn toward the Moyaone. While I
  regularly trim back trees and shrubs to improve visibility,
  the sight line is still compromised.
- When approaching the intersection from the Moyaone during sunrise and the following hour or so, especially in the winter months, the bright sun can blind a driver approaching the intersection.
- On our side of Bryan Point Road, there is a significant dip in the roadway, and there are no shoulders adjacent to the road. Instead there is a ditch that is often muddy or water-filled.
- Drivers approaching the intersection from the Moyaone side often come through so fast that they pass by our house in the opposing traffic lane.
- Many drivers fail to stop at all when turning right from Farmington Road West onto Bryan Point Road, and some make the turn wide, i.e., they end up in the oncoming lane.
- Some drivers even make a left turn from Farmington Road West onto Bryan Point Road without stopping.

#### Roads in and around the Moyaone

I was recently asked by Ben Kirkup, Moyaone Association President, to address a recurring issue related to the roads, specifically access to the Moyaone between Livingston Road and Sanford Lane. While this road is not part of the Moyaone, it is a very important access road—both for entering and leaving, and certainly for use of emergency vehicles. Moyaone residents, visitors, and delivery trucks are able to use this road; however, it is maintained by the Moyaone Association with an unwritten cooperative agreement. In general, we have maintained a good working relationship and have worked to communicate regularly on upcoming roadwork and issue resolution.

Most recently, concerns have arisen (again) about speeding on this stretch, and this note is intended to remind everyone that speeding both damages the gravel road, and is a threat to pedestrians and animals (domestic and wild) and therefore a safety issue. It also results in excess wear, and creates dust and noise that none of us would want in our front yards. Moyaone Roads Chair Kent, and I, both urge all of you who use this stretch of road to be conscious of the speed limit (15 mph maximum on the Moyaone gravel roads), and to remind your visitors and delivery folks to be compliant as well.

- Many drivers are observed trying to manage the turns while holding a phone.
- Even more drivers fail to use turn signals.

I wish it weren't so easy to see all of this. But many of our windows face the intersection, and we both spend a lot of time outside. Incidentally, it's not just "outsiders" who exhibit these dangerous driving habits. Regrettably, we witness many local residents from the Moyaone and other nearby neighborhoods, as well as staff from both Foundations, who engage in these unsafe behaviors.

After the two accidents that occurred just days apart in late November, a number of ideas were put forth on the NextDoor Moyaone forum. Among these were making this intersection a four-way STOP, and/or installing speed bumps on the roads.

Please: NO to both! It is loud enough and busy enough at this intersection already. More starting and stopping will make this a noisier and dirtier intersection (I should also note that people often throw trash out their windows when stopped at the STOP sign). All that starting and stopping will also increase air pollution around the intersection.

In lieu of those radical measures, may I respectfully suggest the following:

- Compliance and Common Sense: Respect the STOP sign and use turn signals.
- Courtesy and Civility: Be kind and pay attention.
- *Caution:* Simply slow down as you approach the intersection when you have the right-of-way.
- *Mindfulness:* You're driving. Stop multi-tasking and put down the phone.

This plea alone cannot prevent another accident. We're all in this together. It is my sincere hope to increase awareness and foster a safer intersection.



# Moyaone Roads: In Case of Snow and Other Policies

Were snow to reach 3 inches in depth, the Moyaone Association's hired snowplow kicks into gear, with thanks particularly to those whose volunteered Moyaone Association consolidated fees pay for his blade clearing a path for you.

As in seasons before, please know that his rig is hired only for our gravel roads. If you have any questions regarding his work, please direct them to me; he's got lots of miles ahead of him to clear, to keep us safe.

If you wish your driveway cleared of snow, among the plows-forhire are the persons below. Residents are welcome to contact them or others, and arrange individual contracts with them. Remember to use NO salt where it could touch the gravel roads. The chemistry of the salt ruins the gravel road, leading to an expensive repair.

As for other gravel road TLC, and driver awareness whenever behind the wheel (I support both Rita's and Shane's separate yet related narratives on page 2), please consider the merit of checking with your local road captain or with me, if there is a road, gutter, tree, or other issue on your stretch of gravel.

Many of the Roads Captains, myself included, have chains, trucks, saws, winches, and other equipment to happily remove trees or ditch-bound autos. Indeed we also have the good fortune of professional help-for-hire. Nevertheless, it makes it easiest to track the Roads budget's expenditures (for work beyond what the Captains and Chair can assist with), if a quick phone call or email to me is made—to discuss options—before any work is started.



# Dear Neighbors, particularly those living in District 9 (Prince George's County):

This is what occurred during the District Council Work Session on CR 62-2017 (on Jan. 30), the resolution to bring MXT (mixed use transportation) development to eight areas in District 9.

The Council heard a summary of the written and oral testimony presented during the joint public hearing with the Planning Board. It accepted a late-filed written testimony of Ms. McKee of Brandywine to be part of the official record. Ms McKee opposed the resolution. Finally, rather than voting on the matter today, Councilman Franklin moved to take the matter under advisement. The Council has until March 9, 2018 to act on the resolution.

In a surprising turn of events, the Council's attorney, Karen Zavakos, stated she disagreed with the legal opinion of Planning Board's attorney and believed that resolution was permissible or would "enhance the vision of certain plans" already created, mainly the Central Branch Avenue Plan (near Suitland and Naylor Roads), which has absolutely nothing to do with the eight areas in District 9 that, if granted, will see unfettered development under MXT zoning designation.

MXT has no limits on the type development or how much development can be done in an area so its designation should not be taken lightly.

Therefore, I urge residents to call all nine Council persons as many times as possible between now and March 9 to kindly urge them to listen to the majority of oral and written testimony of the public and vote against CR 62-2017.

They should be reminded that developers should use the normal zoning process to re-zone their properties and should not circumvent local zoning ordinance for action without true public input, especially since the public does not know what specifically is being proposed for each development.
