Suit Finally to be Heard

The date for the hearing of the Moyaone suit to overturn the industrial zoning granted by the Charles County Commissioners to Columbia Liquid Natural Gas one-half mile from the Reserve has been set for Monday, November 20th at 1:30 p.m. in the Circuit Court at LaPlata.

For more than two years, the Moyaone Association and its landowners have been fighting the rezoning which would allow CLNG to build three gas-fueled, turbine-driven compressors on 16 acres off New Marshall Hall Road. The zoning would "change the neighborhood," opening the door for industrial zoning for other industries in the surrounding land.

In the suit the Moyaone Association, the Piscataway Company, Helen Magargle and William Moran are charging that the value of their land would be decreased by the noisy 13,500 horsepower turbines.

The initial phase of the project is well under way, and the first milestone was the Maryland Historical Trust's (MHT) approval of the research design submitted by Robinson and Associates, the Moyaone consultants. Eleven houses have been surveyed, and this will result in the preparation of the draft version of the completed forms and photographs for inclusion in the Maryland Inventory of Historic Properties (MIHP). In addition, this information will support the preparation of the application nomination for designation as a National Historic District. The draft MIHP forms will be submitted to the MHT for review by the time of publication of this issue of *Smoke Signals*. Our first project status with Robinson and Associates was held on March 18, and they are on track for completion of Phase I by June 15, 2019.

We are greatly appreciative of Karen Hoagberg and Holly Wagner for compiling the archive of *Smoke Signals* going back to 1952 (!), as well as to Scott and Dottie Odell for contributing historical material including photographs from previous efforts they performed to document houses in the community. All these materials were provided to our consultants to assist in their research and completing their work.

Michael Leventhal and I have separately met with elected officials in Prince George's and Charles counties to secure additional funds for Phase II. An application for grant money from PG County Commissioners under the sponsorship of Council Member Sidney Harrison is to be submitted within the next few days. We are awaiting to hear about the next steps from Charles County Commissioner Amanda Stewart. We have also submitted a grant proposal to Preservation Maryland on March 15 and hope to hear a disposition on awards by early May.

VEGAN CHILE RECIPE

Here's how I remember making my "2nd place Chile Cook-off Dish" Was so excited to win the picture. I tried to reconstruct what I put in, but alas I have no exact measurements nor a reliable memory. So I suggest incorporating what you like that I did and have fun with the rest- And just think- it was a never to be repeated dish. Regards, Gwen

Firstly, I used ~2T pesto flavored olive oil to saute two large, sweet onions, ~2 C shredded carrots, 6 Large Mushrooms, and at least a Tablespoon + of prepared minced garlic. After they started to soften- at least 15 minutes I added $\frac{3}{4}$ bottle of red basement wine. This is how we refer to the wine that we have had since we moved to Accokeek, (13years). We had started drinking it but didn't like, but it proved to be a winning cooking wine.

Secondly I started adding the beans and seasonings. I had cooked black beans with a fair amount of cooking liquid, probably added 4 cups of black beans with at least a cup of their liquid. Next 3 cups of a cooked Black Dal called URAD WHOLE MATPE Beans. (These were purchased at HMart in Ellicott City).

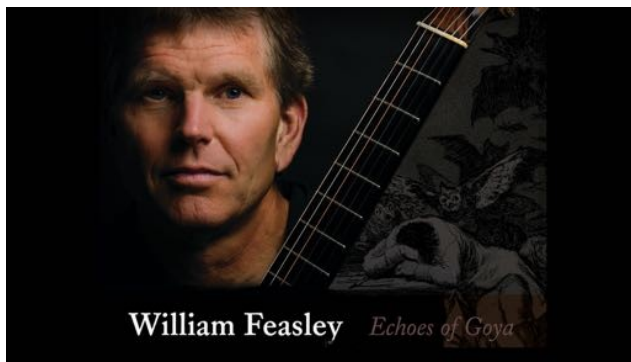
2 Cans of Jack Fruit (from MOM'S) which I separated into shreds and cut up as I emptied the ~15oz. Cans went in next.

Added next was a large can of Muir Glen organic fire roasted diced tomatoes.

Here's the weird ingredient: I had ~3 cups of Vegan Taco filling in my freezer that I had made with Pinto beans and black beans seasoned with no-salt Taco seasoning from Frontier that I threw in.

Then the seasonings- this is where you can have fun with and do your own thing- all amounts are approximate since I was "sprinkling and spooning": Garlic Powder, prepared canned Chile Powder (at least 2 T), Cumin <1T, Dal Seasoning called Dal Makhani Masala ~2T, Green top ADOBO at least 2Tsp., All Purpose Herbal blend by Frontier Herbs (Mom's Bulk) at least 2T, Kirkland No-Salt Organic Seasoning, ~1T, Juice from a fresh lemon, and $\frac{1}{4}$ of a 35.3oz jar of pitted Sicilian Castelvetrano Green Olives (BJ's). Cook as long as you have before the contest begins.

31st Annual Potomac River Cleanup Takes Place Saturday, April 13

Thousands of residents across Washington DC, Maryland, and Virginia will come together on Saturday, April 13 as part of the 31st Annual Potomac River Watershed Cleanup (#PotomacCleanup). Since 1989, the Alice Ferguson Foundation (AFF) has coordinated the Annual Potomac River Watershed Cleanup, engaging more than 150,000 volunteers, nearly 500 partner organizations, and removing more than 7.5 million pounds of trash from the Potomac River Watershed. The majority of cleanups will be held on Saturday, April 13, from 9:00 am to noon. There will be additional cleanups scheduled throughout April.

AFF is partnering with the Accokeek Foundation for the cleanup event at Piscataway Park on April 13. *Please note that the check-in/registration location for this year's event has changed. Volunteers will meet at the Accokeek Creek site in Piscataway Park, 2613 Bryan Point Road.

This is a family-friendly volunteer event. Help make sure trash and litter don't end up in the ocean. No registration necessary. Gloves and trash bags provided. Please dress in sturdy shoes that you don't mind getting wet or muddy. The shoreline in the park can be slick and has a lot of driftwood. Groups are welcome. Accokeek Foundation Presents Land and River Conversations

The group will talk about the most important stories to tell, determine which overarching concepts best represent local narratives, and begin to identify interpretive themes. Piscataway Bio-Energy Project at WSSC

— *Washington Suburban Sanitary Commission*

A project currently in the design phase at the Piscataway Water Resource Recovery Facility is transforming the way Washington Suburban Sanitary Commission (WSSC) handles waste from five existing treatment plants. The Piscataway Bio-Energy Project will employ innovative technologies to recover resources and produce green energy. In the coming years, the Piscataway plant will evolve into a bio-energy production facility that uses efficiency, technology, and sustainability to enhance the financial and environmental health of the region. This \$250 million project will serve WSSC customers for the next 100 years.

The Bio-Energy Project will transform how WSSC handles biosolids from five existing WSSC water resource recovery facilities (formerly known as wastewater treatment plants). The new facility will significantly reduce the amount of biosolids left over from the treatment process, thus reducing costs to haul and dispose of the product. The remaining biosolids will be significantly cleaner (Class A), making the disposal process much easier and allowing the final product to be sold and distributed as fertilizer.

Phase One of the project is now under way and includes design and early construction, which entails demolition of existing on-site facilities and relocation of existing utilities. Phase Two is expected to be awarded in fall 2019. The entire project should be complete and operational in spring 2024.

210 Construction Completion Date Set for 2021

The Maryland Dept. of Transportation State Highway Administration (MDOT SHA) continues its \$82 million interchange construction project on MD 210 (Indian Head Highway) from south of I-95/I-495 to north of Palmer Road in Prince George's County.

The project has reached the 55% completion mark and construction activity on the project continues. However, additional utility relocations must take place before subsequent road work can begin, which requires an adjustment to the project's estimated completion date of late Summer 2020. The project's new estimated completion date is Year-End 2021.

Progress permitting, all utility relocation work should be complete by late Fall 2019. Currently, crews continue to perform road widening work on MD 210 between Livingston Road and Wilson Bridge Drive. Project activity scheduled to begin once utility relocations are complete include bridge construction for the interchange at Kerby Hill Road/Livingston Road and the completion of construction on the project's sound barriers.

Volunteers Prepare Moyaone Pool for Opening Day

Now that spring has really arrived, can the opening of the Moyaone pool be far behind? Volunteers began work to get the pool ready for opening day by removing the pool cover on a recent Saturday.

The pool, located at 2311 Bryan Point Road, is next to the Wagner Community Center and open from Memorial Day to Labor Day.
