President's Note: **The Speed of Progress**

In providing another progress report on a variety of projects affecting the Moyaone, it is good to know that the movement is not always at a glacial pace, despite seeming so. The progress is steady but requires patience to monitor the action, which sometimes has a life of its own. That said, here is where we are on the following projects:

New septic system. The new septic system is now installed. There are a few minor aspects that need to be attended to in the coming weeks, but the system is functional and operational. According to the State, the County, the manufacturers of the various system components, and the contractor, the new septic system (the four tanks and the drain field) CANNOT be driven on. The drain field needs to be ringed off to prevent vehicles from driving or parking on it. The drain field can only have grass growing on it – no plants or trees that have a deep root system. There are most likely a variety of grasses and shallow root plants/flowers that can be considered as well as some type of plants to go between the bollards that have already been set along the north and west perimeter of the septic drain field. I encourage all of our plant and grass experts to contact John Hollyfield (Chair/ Building and Grounds) with possible recommendations.

This project would never have gotten to this point had it not been for Nan Fremont taking it on from the beginning. She led the effort to get the bids; talked to the contractors; dealt with the County and the State through numerous phone calls and meetings; helped secure the grant to pay for part of the system; worked to get the contractor to set dates to begin; and dealt with all of my nagging, and perhaps pointless, questions ... many of which were rhetorical. For all of this work, and much more, Nan deserves a community-wide

thank you and congratulations for a job well done. I would also like to extend my sincere appreciation to John Hollyfield, who also worked on this project from the beginning. He made himself always available to help the contractor in any way that was needed. John also deserves a community-wide thank you.

I don't know if in the spring we should have a celebration for the new septic system. Perhaps a ceremonial flush for all of our past issues with the old system. We are certainly now number 1 in the number 2 department with our advanced environmental septic tanks. The new "do's and don'ts" for the new system will be posted throughout both bathrooms to help users with what can and cannot go into the system.

Charles County Scenic Easement Tax Credits. The next step is meeting with Commissioner Thomasina Coates, representing District 2 (which includes the Charles County portion of the Moyaone Reserve), now scheduled for April 22. Commissioner Coates has been busy lobbying for Charles County in Annapolis while the General Assembly has been in session. Hopefully after meeting with her, she will be supportive of an ordinance allowing for a tax credit off those property bills for having a scenic easement to protect the viewshed of Mt. Vernon. Commission President Reuben Collins has indicated his support, as has the Charles County Chief of Treasury.

Prince George's County tax assessments for Moyaone Association-owned property. The Maryland Department of Natural Resources Forest Service toured the Moyaone Association-owned property to determine if a forest plan could be developed. The initial assessment following the tour was that a forest plan would be suitable for these properties. Having such a plan registered with the State and County would allow for a lower tax assessment on these properties. This new forest plan

should be developed and sent to us in the coming months. More updates to follow.

Proposed Royal Farms project. The ongoing Zoning Hearing Examiner (ZHE) meeting continues without any decision or resolution to date. A central issue for the Moyaone Reserve is the traffic safety problems that could develop at the 210/Indian Head Highway and Livingston Road intersection. Royal Farms has not directly given any information as to the number of vehicles it expects to visit this proposed location on any given day. They have indicated that they expect to deliver 30,000 gallons of gas every day or two. If the mean gas fill-up is 20 gallons, that would equate to 1,500 cars. The entry into the proposed Royal Farms site is about 150 feet west of the 210/Livingston Road intersection. The B&J's entry is about 75 feet from this intersection. There is not enough space (lanes and distance) to have this many new vehicles at this point without back-ups onto Indian Head Highway. At press time, ZHE had scheduled another hearing on March 5. More updates to follow.

Board Nominating Committee Formed

According to the By-Laws of the Moyaone Association, each year a Nominating Committee is to be created in February to develop a slate of names for the 5 officer positions that make up the Board of Directors. This year's newly formed Nominating Committee will be made up of Mary Lee Phelps (mlgp42@msn.com), Ben Kirkup (bckirkup@post.harvard.edu), and Tina Shotwell (clnienaber@gmail.com).

Of the 5 Board officers, two positions are for 2 years (Comptroller and Secretary), while the other 3 are for 1 year (President, Vice-President, and At-Large). The current Comptroller, Paola Addamiano-Carts, has 1 year left to serve. Two of the current Board (Samantha Katz/Secretary and Karen Hoagberg/At-Large) will be rotating off the Board this May. The other two current Board members (Rose Kim/Vice-President and myself/President) are hoping to continue to serve on the Board, but in different positions.

It is unreasonable to think that the Nominating Committee could know everyone in the Moyaone. If anyone is interested in becoming a member of the Board of Directors, please contact one of the individuals serving on the Nominating Committee. While doing community service is rewarding, do note that all of the Board positions involve time and generally a project responsibility. The Board meets once a month, with several additional meetings when developing the annual budget and when there is an issue that requires an additional gathering. All officers must be members in good standing of the Moyaone Association.



National Historic Register Application Approved

Great news! On Feb. 18, the Moyaone's application for the National Register was unanimously approved by the Governor's Consulting Committee. Furthermore, they were very complimentary on the application itself. Kudos to our consultants, Daria Gasparini and Mike Mitchell of Robinson and Associates, for preparing a superb, high-quality application. The final nomination is on track for submission to the National Park Service in mid-March. NPS then has 45 days to review and act, and we should receive a notice regarding the disposition a few weeks thereafter. If any questions should arise during the NPS review, the nomination is held until those are addressed, and so technically that might extend the review time. A copy of the overview presentation given by Daria Gasparini at the Moyaone Community meeting on Jan. 25 will be available on the newly designed Moyaone website once it is up and running.

Thanks to the Alice Ferguson Foundation, Accokeek Foundation, and the Mount Vernon Ladies Association for providing letters of support for our application. While these letters are not part of the application per se, they are incorporated into the official file.

A minor correction was noted by two residents (Herb Savage and Stan Fetter) to the legal notice that listed the boundaries for the Moyaone, and it was reported to the Maryland Historical Trust. It should have read: "roughly bounded by Bryan Point Road [previously incorrectly stated as "Bryant Road"] and Piscataway Park on the North; Overlook Drive/Old Landing Road on the West; the southern boundary of Piscataway Park on the South; and Farmington Road W. on the East."

In thinking about next steps, we would like to order a historic plaque to be posted at the Moyaone Association's Wagner Community Center. Bronze plaques cost roughly between \$500 and \$600, so we are seeking contributions to defray the cost.
