### Another Bump in the Road (With Kudos to the Road Crew)

I knew when the power went out during the severe weather we had on May 19 that a tree might be down, so I phoned my son to pick up dinner on the way home. When he arrived on foot, my suspicion was confirmed — a large tree had taken down wires on "our hill."

Over time, "our hill" has been declared by numerous road chairs and grader operators as one of the worst-designed roads in the Moyaone Reserve. It's very steep and has a sharp curve before it levels out to our driveway. Tom and I moved to the bottom of this hill on West Auburn in 1968. We were the first to live at the end of West Auburn, so it had never been maintained. When we purchased the land, I said I wouldn't move in unless we had four-wheel drive. Tom agreed and we bought a used International Scout and later upgraded to a Land Rover. That was more than 50 years ago and the roads were in very poor shape at that time. Tom served as Roads Chair for many years and worked hard to get things in better shape. I want to go on record stating things have been greatly improved as witnessed by this recent "bump in the road." Also, I should clarify that "our hill" is technically not ours. We have a neighbor living at the bottom with us now, and thankfully the road is owned and maintained by the community. I just feel ownership!

I have many stories about living at the bottom of "our hill," and the big tree felled by a microburst (small tornado) on May 19 is definitely in the top three. I should qualify that my choice for number one was when a tractor trailer full of pet food mistakenly drove down our hill one July afternoon in the mid 1970s. The driver was supposed to deliver 10 bags of dog food to the Kanslers via East Auburn, but he took the wrong Auburn - and ended up at the bottom of our hill. It took three large tow trucks at least 6 hours to tow the truck up and out! Neighbors gathered on the hillside with refreshments to watch the struggle. When the tractor trailer was safely up the hill there was much applause — followed by a Moyaone-type happy hour. A second event was with a Green Spring Dairy truck making a delivery to us. After heavy rains we were often challenged by mud-filled sinkholes where our car tires would sink up to the rims. Tom and I learned how to drive up without stopping, March always worse with freezing and thawing. On one of those days the milk truck came down the hill but then couldn't get up. After several tries, he surrendered. I offered to help and the driver reluctantly agreed. I put our three kids, who were preschoolers at the time, in the back of the Scout. Together with our synchronized driving we made it up the hill. That inspired me to make a homemade ROAD CLOSED sign to prevent visitors from coming down when the road was impassable.

This week's downed tree definitely qualifies as my number three. Thursday morning I went up to check storm damage and found the road blocked by a very large hickory tree with a trunk that was approximately 3 feet in diameter. My son Roger cleared numerous branches and when we got to the fallen tree, I decided I could probably drive under it. Roger spotted me as I drove to be sure I wouldn't damage our car. I was

successful, having about a foot of clearance. I called Stan Fetter, Roads Chair and neighbor, to tell him we had a big problem. Within an hour he had checked it out and reported that a crew would arrive later that day to work on the clearing.

Later that morning the Roads Committee contract labor team of Leon, Troy, and Dave arrived, assisted by several community volunteers. On Thursday they removed numerous branches and big limbs so they would have safe access to cut and clear the trunk from the road the next day. Friday morning, as I was leaving for an early appointment, I was able again to drive under the tree. I waved as the crew was gathering for another day's work. This time on my return at noon I was blocked! The tree was now in many large pieces all across the road. I took pictures as I walked down our hill to home. Finally, at 4 pm the road was cleared. They couldn't have removed this tree without the community's Gradall and its expert operators. To top things off, the tree damaged our cable wire and we are waiting for repairs as I write. A rainy holiday weekend without television, internet, and phone meant returning to time-tested leisure activities -books, writing letters, and puzzles. It's okay. No longer the wife of the Roads Chair, I'm grateful to not be hauling branches out of the way and making signs that say ROAD CLOSED. Meanwhile, I am especially grateful to all those who pitch in to keep our roads maintained and cleared of fallen trees.

NPS proposes to reduce overabundant deer populations in several national parks in DC and Maryland. We encourage park neighbors and visitors to review and share comments on a NPS proposal to develop a deer management plan and environmental assessment (EA) for National Capital Parks—East, which includes, among others, Fort Washington Park, Fort Foote, Piscataway Park, Oxon Cove Park, and Harmony Hall,

The purpose of this proposal is to develop a white-tailed deer management strategy that supports long-term protection, preservation, and restoration of native plants and landscapes in these parks.

How to comment: Public participation is vital to the planning process. You are invited to review the proposal and provide comments and ideas from June 15 through July 15. ### GACA to Meet Virtually June 30

The Greater Accokeek Civic Association (GACA) will host a virtual general membership meeting on Wednesday, June 30, at 7:30 pm. Detailed "Zoom" instructions will be sent via email closer to the meeting date. The program will include updates on a variety of issues of interest to the community, such as the Roadway Advisory Committee for South County (RACS), GACA's ad hoc committee that has been working with the Maryland Department of Transportation and Prince George's County's Councilmanic District 9 representatives on managed maintenance and aesthetic issues along South County roadways (for example, regular mowing, illegal dumping, and the use of portable security cameras). Staff from Councilman Sydney Harrison's office will also participate in the meeting.

Cpl. Rannacher, our local Prince George's County District VII Police Department community officer, will give his report.

Theresa Cullen, AFF Executive Director, said that "We are thrilled to host CCYO once again at Hard Bargain Farm. The great outdoors provides the perfect backdrop for these young musicians to showcase their talents."

For the 1 pm concert Prelude Strings, directed by Dr Teri Lazar, performed a program of music by Vivaldi, Clark and the soundtrack from the movie *Charlie and the Chocolate Factory*. The Encore Band, directed by Takako Mato, performed pieces by Merken, Shaffer, and Joplin. ### **Grace Griffith**

October 30, 1956 - June 5, 2021

Grace was born on October 30, 1956, the eighth of ten children. She grew up in Charles County, MD. As a child, Grace liked to draw and loved music. A drawing that she did when she was five years old was sent to Thomas Merton and inspired him to write the poem "Grace's House," which some Merton commentators consider one of his finest. In the liner notes for one of the music albums she eventually recorded, Grace recalled that when she was ten years old, her mother gave her a recorder and she would spend hours playing it in the woods on her parents' property.

Grace attended Archbishop Neale School in LaPlata, MD, and went on to graduate from the University of Maryland with a degree in physical therapy. Upon graduation, she returned to Charles County where she worked as a physical therapist at, among other places, then-Physicians Memorial Hospital in La Plata. Grace was a dedicated caregiver who drew great satisfaction from her profession. Sadly, her career as a physical therapist was brought to a premature end by Parkinson's disease.

Music was Grace's avocation and lasting passion. She believed that physical therapy and music had a common thread in that they both promoted healing. As Grace grew up, she developed into a talented singer and instrumentalist. Among other instruments, she played the guitar, penny whistle, recorder, dulcimer, and even tried her hand at electric bass. The genres of music she leaned toward were folk and Celtic. After college, she began appearing at various venues in Southern Maryland. Eventually, her performances expanded to the greater Washington/Baltimore area and beyond.

Grace recorded many critically acclaimed albums, including: Every Hue and Shade, Sands of Time, Grace, Sailing, Minstrel Song, My Life, and Passing Through. With A memorial service will be held for Grace Griffith on Sunday, June 27, at 2 pm at the Alice Ferguson Foundation Cafritz Center, 2201 Bryan Point Road, Accokeek.

Connemara she recorded *Siren Song* and *Beyond the Horizon*. A number of her CDs were released by the Blix Street label.

Grace performed with many groups, including The Hags, Hazelwood, Connemara, Irish Fire, Jennifer Cutting's Ocean Orchestra, and Cathy Fink & Marcy Marxer. She appeared at many venues with those groups and with many other musicians. Over the years, Grace's music was recognized internationally. Locally, the Washington Area Music Association awarded Grace Griffith WAMMIE awards as "Best Female Vocalist" in both the Celtic and Traditional Folk categories four consecutive years.

Grace was preceded in death by her parents Bert and Lucile Sisson; her sister Maura Sisson (Richard Hesse); her brothers Fred (DeeDee), James (Nancy), and Mark. She is survived by her husband Patrick Holmes and her siblings: Richard (Marybeth), Bridget Sisson (Oren Swain), Clare Barrow (Ted), Michael Sisson, and Joseph Sisson (Janet Silverman). She is also survived by her nephews and nieces: Francis Sisson (Erica), Jane Barrow (Steven), Caitlin Lackey (Brandon), Jamie Sisson, Thomas Barrow (Rebecca), Christine Alexander (Daniel), and Molly Sisson along with two grandnephews, eight grandnieces, many cousins, a multitude of friends, and her other family — the many musicians she had the pleasure of making music with. In this last regard, it has been said that Grace had two families — her biological family and her music family. Grace once said that for her making music was like being next to God. Music remained a great source of solace and joy until her end. Even as Parkinson's disease caused the clarity of her speech to fade, she would still sing and the lyrics consistently came out clearly.
