## Heritage Fund Highlight: Moyaone Reserve Historic District

Next to the Potomac River, contiguous with Piscataway Park, is the mid-century community of Moyaone Reserve.

Preservation Maryland's Heritage Fund, in partnership with the Maryland Historical Trust, recently helped fund the costs associated with the nomination of Moyaone Reserve to the National Register of Historic Places.

The nomination process was spearheaded by the Moyaone Association. In addition to the Heritage Fund, funding was provided by the Mount Vernon Ladies Association and Prince George's County.

The National Register of Historic Places is the official list of the Nation's historic places worthy of preservation.

Authorized by the National Historic Preservation Act of 1966, the National Park Service's National Register of Historic Places is part of a national program to coordinate and support public and private efforts to identify, evaluate, and protect America's historic and archeological resources.

The new Moyaone Reserve Historic District will encompass over 120 contributing single-family homes along with undeveloped parcels including protected marshland and the mid-century Wagner Community Center. The homes showcase a range of styles and many of them are designed to work in visual harmony with the natural environment that surrounds them.

This connection to the natural environment was present in the community from the beginning of planning for the neighborhood as a place that sought to protect the rural, wooded area where the houses were built. Modernist architect Charles F. Wagner, Jr. built his own home in the community along with over 15 additional homes in the community.

### Join the MOYAONE CHALLENGE on September 11

Join the **Moyaone Challenge** on Saturday, September 11 by entering one or up to two of the four events—Triathlon, Swimming, Biking, or Running. There will be three different age groups: Youth 10–18, Adult 19–59, Senior 60 and over. All events begin at the Moyaone Association's



Wagner Community Center, 2311 Bryan Point Road.

We will also have two events for kids aged 5–9. One will be an intergenerational, family relay that will include running 3 lengths of the garden. Family members and siblings are encouraged to participate. We will also have a distance soccer ball kick event. These events will be held in the soccer field starting approximately at 9 am. Registration is \$5 for either or both events.

### Triathlon

Begins at 8 am and includes swimming, biking, and running. This includes a 250-m distance (10 pool lengths; no flippers allowed); a 8 km/5 mi bike ride; and a 2 km/1.2 mi run. **Bike helmets are required.** Transition time from one element of the race to the next is included in the total race time. Individuals or relay teams may enter. Early registration by Aug. 31 is \$25; after Aug. 31, \$30.

### Swim Challenge

Begins at approximately 8:30 am, after Triathlon Challenge has completed. All strokes are accepted including walking,

but no flippers are allowed. Distance is 250 m (10 pool lengths. Early registration by Aug. 31, \$15; after Aug. 31, \$20.

### Biking Challenge

Begins at approximately 8:45 am. Distance is 8 km/5 mi. **Bike helmets are required**. Early registration by Aug. 31, \$15; after Aug. 31, \$20.

### Running Challenge

Begins at approximately 9 am. Distance is 2 km/1.2 mi. Walking is permitted. Early registration by Aug. 31, \$15; after Aug. 31, \$20.
