## *President's Note:* Moyaone Association Meets Dec. 11

I'm looking forward to greeting friends and neighbors at the December 11 (3:00 pm) Moyaone Association (MA) Budget Meeting at the Wagner Community Building (2311 Bryan Point Rd.). MA Secretary Lona Powell emailed a meeting packet to all community members a few weeks ago; if you did not receive the packet, please email Lona at MoyaoneSecretary@gmail.com to request another copy. The meeting will kick-off with a discussion on the unique relationship and history between Piscataway Park and the Moyaone Reserve, led by Laura Ford, CEO of the Accokeek Foundation, and Michael Commisso, Acting Deputy Superintendent of the National Park Service. During the budget portion of the meeting, the membership will vote to approve the 2022 budget as well as vote on capital expenditures. Please bring a favorite snack and beverage to share with friends and neighbors after the meeting. We did not care to publish the budget materials but if you would like a copy, please reach out to Lona and she will send you the full meeting packet that includes the budget.

We do ask that you arrive at 2:45 pm to check-in for the meeting; this is especially important if you are checking in for yourself and as a proxy. We have a lot to cover and this will help us start on time.

As we think about the 2022 budget, I want to share some numbers:

The position will start in March with limited hours to prepare the pool for opening Memorial Day weekend. From Memorial Day weekend through the week after Labor Day, the position will be 30 hours per week paid hourly. The pay rate is commensurate with experience and qualifications.

## December 2021 Greater Accokeek Civic Association News

The GACA Board -- President, Judy Allen-Leventhal; Vice President, Trey Thomas; Secretary, Lee Puterbaugh; Treasurer, Erica Barry; and members-at-large, Roger Midgette, Phil VanWiltenburg, Dan Donohue, Stevenson McIlvaine, and William Centeno - has continued behindthe-scenes work although the last general GACA membership meeting was held in June. Phil VanWiltenburg continues to reach out via email with important information from a variety of sources. The Roadway Advocacy Committee for South County (RACS) - Larry Bettis, Brinson Evans, Colleen Walter Puterbaugh, and Joan Smuck continues work with Maryland Department of Transportation (MDOT) and Prince George's County's Councilmanic District 9 - as you may have noticed, in particular along Maryland Route 210, its frontage roads near the Route 373 intersection, and along Livingston Road.

We want to extend special thanks to the MDOT Upper Marlboro shop team for their invaluable work in making the Oct. 30 Growing Green with Pride Prince George's County event a great success. Special thanks to MDOT's Ernie Johnson and Jamaal Craven for their leadership, which was invaluable in helping the GACA volunteers complete the planting and litter pickup along north- and southbound Maryland 210 frontage roads.

Consultant Carolyn Brackett and members of the Neighborhood Design Center consultant team met with various local stakeholders and visited local resources. ## Moyaone Association Annual Meeting Minutes May 15, 2021 Wagner Center Pavilion, 2311 Bryan Point Rd. Accokeek MD 20607

## **Call to Order**

A quorum was verified and the meeting was called to order by president, Rose Kim at 3:13.

## President

Rose thanked everyone for coming and acknoweged several "unsung heros" in our midst, specifically Alex Naar and Antonia Bookbinder (for their work combatting invasive species in the commons area), Holly Wagner (planting native plants around the buildings), Rita Bergman (National Register Nomination), Gary Penn (our webmaster), Paul Murray (our website), Chris Ailes (cleanup) and Ruth Gaumond (editor, Smoke Signals).

Rose introduced several community partners that had been invited to briefly speak:

Laura Ford, President and CEO of the Accokeek Foundation. Laura said that going forward the Visitor's Center will be open every weekend and there is also a twitch stream that will be up all month. She acknowledged that we are on Piscataway Nation homeland and that they are working on putting the Piscataway back into Piscataway Park.

<u>Theresa Cullen of the Alice Ferguson Foundation</u>. Theresa spoke briefly about the programs that they had been able to continue and thought that the children will be back sometime next year. They have a mission both to "get people outdoors" and to "keep the environment healthy". They have the "Pinot on the Potomac" fundraiser coming up in June, and later, on October 8, a community picnic.

Judy Allen-Leventhal, President of the Greater Accokeek Civic Association (GACA). Judy spoke of some GACA initiatives like highway cleanup and advocating for our fair share of highway money. She is also working with MNCPPC on the Accokeek Heritage Tourism Plan, which will involve a consultant coming down to identify stakeholders and resources then producing a plan.

Leanne Erwin, from the Prince Georges County Lynching Project. She is working on getting historic markers put up where lynchings took place, including one in Piscataway in 1869. Promoting racial justice is the goal of the project.

## Comptroller

Paola said we have \$82K in the bank account. 70% of homeowners have paid. Paola said that during her two years as comptroller she was impressed by the stewardship of the board in deciding how to spend the money. Paola gave a shoutout to Rose for being very proactive in getting people to pay their fees and to Michael Leventhal for working tenaciously to save us thousands in property taxes.

## **Chair and Standing Committees Report**

## Financial Trustees & T. Rowe Price

Stan Fetter reported that we have \$319 in the accounts, up \$78K from a year ago. The audit of the books showed good recordkeeping with transparency in the records.

## Membership

Crystal Garcia mentioned that there were lots of new neighbors in attendance and she encouraged them to each introduce themselves, which they did. The new people included a block of homeowners from the Howe Estates, which were recently annexed into the Moyaone Reserve.

## Roads

Stan Fetter reported that the roads are in decent shape with some culvert work coming up. We got some free material that will save us thousands of dollars. People will be informed as the time gets closer – June or July is the timeframe, since there will be a time when the roads will be impassable. Stan also reminded all to take care of the brush along your road frontage, look at your trees and take care of them if they are ready to come down. He also reminded us that Sanford Lane is not ours and we need to drive slowly and carefully when using that road.

## Pool

Rhonda Hansen reminded everyone that pool membership is included in the fees. She said the pool inspection would be on Wednesday, May 19, and that May 29<sup>th</sup> is the opening. Rhonda said that we are bound by a county policy that will still require social distancing and the wearing of masks on the pool deck. The swim team will meet this year, but we are not sure yet if there will be lessons.

## Buildings and Grounds

John Hollyfield talked about the importance of stewardship, then made these important points:

- Off-season the trash cans don't get emptied.
- Don't use match-light charcoal, the flames get too high.
- He found the fire extinguishers empty.
- The water is turned off during the off season.
- A combination can be provided to use the gas but don't give the combination to children.
- Don't put sharp knives where kids can get to them.
- Bring soap, paper towels to events on the grounds.
- If you see a toilet running jiggle the handle.
- The Pizza oven gets to 1000 degrees; its important that kids don't run around it. There is a "Yellow Zone" for the pizza that should not have kids in it.
- Furniture should not be dropped off without checking first.
- The back door of the Wagner Center doesn't latch well be sure to check it.
- Pick up large rocks if you see them in the field.
- Lock the gate if you are the last one out.

John encouraged people to sign up for the Building and Grounds Committee. (At the back were sign up sheets for all the standing committees.)

## Public Affairs

Kent Hibben said he works to coordinate with all of our partners and he encouraged people, especially newcomers, to learn all about the neighborhood that they can. He mentioned two helpful books: <u>Moyaone Reserve</u> by George Hanssen and <u>After Alice</u> by Kay Powell. He also mentioned "The Woods in Your Backyard" as another helpful book, which has best practices for land stewardship.

## **Other business**

The nominating committee of Karen Hoagberg and Rita Bergman presented the following slate: President – Rose Kim Vice President – Lindsay Laws Comptroller – Karen Bell Secretary – Lona Powell Director At Large – Michael Leventhal Financial Trustees – Rita Bergman (to take over Stan's third year), Bill Robertson, Paul Livingston

A motion to approve the slate was made and was approved by the membership.

Michael Leventhal gave an update on his efforts to get scenic easement tax credits for Charles County landowners. There are 44 lots that would be eligible for easements. He has asked Mt. Vernon for help in identifying which properties they would like to see easements on, but these talks have not been fruitful. Michael is waiting to get something from them that he can go back to Charles County with. Holly Wagner clarified that if your easement was bought, back when these were being established, then you do not get a tax credit.

Michael also informed the meeting that Royal Farms has withdrawn its application to develop at the main Accokeek intersection. He also mentioned that a new threat is the expansion of Maryland Airport in Pomonkey. Charles County wants to put commercial development all around it. People were encouraged to express disapproval to the Charles County Planning Commission. John Mitchell spoke briefly on the Fair Skies Coalition that deals with the airport noise issue. The goal is to spread the noise out.

Holly Wagner spoke on an effort underway to try to improve the acoustics in the Wagner Center. An acoustic engineer is being consulted.

The meeting closed with a very moving tribute by Kent Hibben to the 11 Moyaoners who had died during the last year. None of the deaths were from coronavirus. Remembered were Phil Jones, Bev Linde, Judy Bedner, Mike Realo, David Townsend, Ed Jones, Bob and Charlotte Gillespe, Tom Powell, Vince Femia, and Brendan Watts.

Rose presented mementos to Paola Carts and Karen Hoagberg to thank them for their past service.

The meeting adjourned at 4:51 PM and everyone was invited to stay and drink a champagne toast.
