Spring Maintenance, and Legal Matters

We are well into our spring maintenance cycle, with grading and ditch work underway. We again ask everyone to give our crews room to safely work — please don't pass a working machine until you the operator sees you and waves you by.

We do anticipate doing some work on brush along the roads later in the season, but we don't have the budget to handle all of it. So, anything you can do along your road frontage will help (and save \$\$).

Finally, a reminder that we periodically post "Road Closed" signs at each entrance to the Moyaone Reserve for a day or so; this is to legally preserve and reinforce the status of our roads as private and not available for use by the general public. We'll be doing this later in the spring, and we'll send notices out well in advance. The signs will be placed such that motorists can easily get around them, and they are not intended to have any bearing on residents, guests, deliveries, etc. This is purely a legal exercise to fulfill the need for periodic notice to the public at large. 

Community Meeting with Police Officers Focused on Better Communication

On April 21 the Moyaone Reserve community hosted a discussion with police officers from Charles and Prince George's counties and the United States Park Police (USPP). The purpose of the meeting was two-fold: 1) to introduce the community to our local law enforcement representatives, and 2) to have a conversation that will continue the healing process for those who have experienced distress from recent incidents in the community. I'll start with the ending, because it is important to remember, as Major Green with the USPP stated at the end of the evening: the Moyaone Reserve is very safe and has almost no crime. We should feel safe here.

Below are a few points from the officers, followed by their contact details. All enthusiastically welcome your email messages and calls.

- Both Charles and Prince George's officers acknowledged that their departments are grossly understaffed.
- When calling 311 or inquiring about possible crimes in our community, ask "Is there a call for service in our area?" Be prepared to give an address with a street number and/or cross streets.
- If the answer is yes, there is a call for service in your area, your response should be: "Is there anything I should be aware of?"
- A 21st century "phone tree" type system of communication for the Moyaone Reserve only.
- Reevaluate the signage in the neighborhood. Is additional signage needed at entry points (Old Marshall Hall, Sanford Lane, and Cactus Hill from Bryan Point Road are examples)? Please note that because we are within Piscataway National Park, USPP reminded us that signage would need to be approved by the National Park Service.
- USPP Tip Line See below under USPP.
- Officer Rannacher has in the works a plan to help with the unwanted dumping of trash.
- Field training for Charles County to make them aware of who/where we are.
- Invite all three branches to Moyaone social events.
- Charles County <u>cityprotect.com</u>. You can see police activity in the area (thankfully, you see very few blue dots in Accokeek).
- If you see something, take a photo and report suspicious behavior. If the police in Prince George's or Charles counties see a pattern of behavior involving the same individual, they will conduct a "knock & talk."
- The police are powerless to stop ATVs because they

cannot legally chase them down – this is not only illegal but dangerous for all involved. If you are able to photograph or take a license plate number, if there is enough evidence, they can do a knock & talk.

- For those Charles County residents who have been frustrated by 911 operators' inability to understand that they are indeed in Charles County: the officer in attendance recommended that all Charles County residents write individual letters (can be the same letter) to the Charles County Health Department (they are in charge of zoning) and have the packet notarized. The letter should state that you are indeed in Charles County and request that they relook at zoning due to recent concerns.
- For those who travel Bryan Point Road, after our meeting Officer Rannacher placed an electronic speeding sign as a deterrent to those who go too fast on our roads.

MDE Conducts Piscataway Creek (Tidal and Non-Tidal) PFAS Chemicals Study

In late 2020 and early 2021, the Maryland Department of the Environment (MDE) initiated a targeted study of the occurrence of PFAS compounds in surface water and fish tissue in the Piscataway Creek area.

The per-and polyfluoroalkyl substances (PFAS) are a group of chemicals used to make fluoropolymer coatings and products that resist heat, oil, stains, grease, and water. Fluoropolymer coatings can be in a variety of products. These include clothing, furniture, adhesives, food packaging, heat-resistant non-stick cooking surfaces, and the insulation of electrical wire. Many PFAS, including perfluorooctane sulfonic acid (PFOS) and perfluorooctanoic acid (PFOA), are a concern because they do not break down in the environment, can move through soils and contaminate drinking water sources, and build up in fish and wildlife.

The Piscataway Creek study included monitoring for PFAS in surface waters and fish tissue in the tidal and non-tidal waters of Piscataway Creek, and Nanjemoy Creek (a reference site with tidal and non-tidal sampling locations similar to and south of Piscataway Creek with no known PFAS sources). MDE determined that it would be beneficial to sample PFAS levels in surface water and fish tissue in Piscataway Creek to better understand human health risk and potential sources of PFAS. The results and conclusions from this study will be used by MDE to determine the need for more immediate risk reduction actions, such as the issuance of fish advisories.

PG County Library to Present Lynching Memorial Project May 21

"The Untold Story of the 1869 Lynching of Mr. Thomas Juricks in Piscataway"

The Prince George's County Lynching Memorial Project (PGC LMP), in partnership with the Prince George's County Memorial Library System, will offer a presentation on a lesser-known part of community history at the Oxon Hill branch library (6200 Oxon Hill Rd., Oxon Hill) on Saturday, May 21, from 11 am to noon. This in-person event is free and open to the public. For more details, see https://www.pgcmls.info/event/6372270. Event registration is optional; walk-ins are welcome.

Juricks was a laborer and farmhand who lived in the Piscataway area. Contemporary sources such as newspaper articles along with independent research conducted by PGCLMP members informs the presentation about the events of October 12, 1869, when Juricks was extrajudicially murdered by a mob in one of the four documented instances of racial terror lynchings to have taken place in Prince George's County. According to the Equal Justice Initiative, 4,400 such racial terror lynchings took place throughout the country from the 1860s through the end of World War II, and the effects of these traumatic events still reverberate in our communities today. PGCLMP in its presentation will discuss some of those effects, and detail its work in fostering truthtelling and reconciliation about the continuing legacy of the institution of slavery.

Safety and health protocols are in effect. Face masks and physical distancing are required for all participants over age 2.

WSSC to Use New Technology to Improve Handling of Waste at Accokeek Facility

WSSC Water is transforming the way the Piscataway Water Resource Recovery Facility will handle waste from five existing water resource recovery facilities. The Piscataway Bioenergy Project, the largest and most technically advanced project ever constructed by WSSC Water, will use innovative technology to recover resources and produce green energy. In the coming years, the Piscataway plant will evolve into a bioenergy production facility that uses efficiency, technology and sustainability to enhance the region's environmental and financial health. This \$271 million project is expected to serve WSSC customers for the next 100 years.

The Piscataway Bioenergy Project will transform how WSSC Water handles biosolids, the nutrient-rich organic materials produced by the wastewater treatment process. Using cutting-edge technology, the new facility will significantly reduce the amount of biosolids left over from the treatment process, thus reducing costs to haul and dispose of the product. The biosolids will be significantly cleaner "Class A" biosolids, making the disposal process much easier and allowing the final product to be sold and distributed as fertilizer.
