President's Note: **Maintaining Our Community**

Dear Friends and Neighbors,

We have ended the first quarter of 2022 and I'd like to thank those of you who've paid 2022 dues. Many households have stepped up and have either paid their dues in full or have arranged for ACH payments, but there are still many who have not. We deeply appreciate those of you who are able to pay, and we also understand that some would like to pay but are in a financial place where they are not able to do so this year.

While we sometimes use the term "HOA" to describe our system of community management, we are far from it. The founders of Moyaone Reserve decided long ago that our community would not be an HOA and that membership in the community would be voluntary. They were an idealistic bunch, the community was much smaller then, and dues were next to nothing — almost all were members. The founders understood sacrifice and stewardship — many were children of the Depression and/or WWII.

Now, 60 years later, our community has changed. Dues are not next to nothing, although at a cost of about \$65 per month, that's pretty cheap for most of us. That small voluntary payment is stretched a long way by those who manage the community's finances. A lot goes toward managing the pool and maintaining our private roads and there's usually some left over for other projects — some needed, some wanted.

We all want to live in a community with wonderfully maintained roads and a beautiful Commons area and pool that we are proud of and where our children feel safe. You may not live on a private road or use the pool, but these are amenities that affect the perception of your community and give added value to your homes. As many of us have seen the value of our properties increase thanks to COVID and other factors, the amenities that the Moyaone Association owns should be a reflection of the value of your home.

What stays constant for us landowners during change is knowing that uncertainties are faced most easily when hearing the message of our roots. Many who grew up here, and those who arrive seeking connection to (y)our forest's folks, flora, and fauna, find the Founders' facts and focus refreshing.

So, as a cyclical refresher, the original Scenic Easement (see page 10 of this issue), formed through Public Law 93-444 and a December 2020 National Park Service resource, "Preservation and Partners: A History of Piscataway Park" by Janet A. McDonnell, are attached and will also be sent as PDFs attached to a pending Public Affairs Bulletin, alongside Rita Bergman's Fundraising Survey (see a copy of the survey on page 5).

These narratives parallel the Founders' books you perhaps already have (feel free to ask me for copies: KentLHibben@gmail.com) of our history here, such as in *The Possible Dream: Saving George Washington's View* by Robert Ware (Bobby) Straus, Geo. Meeting: Wagner Center Acoustics Improvement?

Saturday, April 23 at 3 pm

3:00 Music by Lynn Hollyfield and Chris Aills
3:30 Meeting, Wagner Ctr., 2311 Bryan Point Rd.

Purpose: To decide whether to recommend proposed Wagner Center acoustic improvements to the annual Moyaone Association Membership Meeting on May 7. How would we present the acoustic problem, namely reverberation, and its realistic remediation?

Professor Ian Hoffman, Peabody Institute, Johns Hopkins, is an architect and acoustic designer as well as educator. He will discuss how the Wagner Center's structure affects sound, and give a demonstration of the effects on speech. Frank Pipitone on the piano will show how the building affects what an audience can hear.

Prof. Hoffman will then discuss the modifications to the building he has suggested that will improve the building's acoustics. They consist of wall panels and baffles hung from the ceiling. Costs, fund raising, and reasons to implement this plan will be covered. The presentation will include recommended improvements that have the lowest cost and sufficient remediation.

We will have a discussion of costs, fund raising, and reasons to implement this plan. After the discussion, there will be a vote about recommending the acoustic remediation of the Wagner Center, which would improve the room's acoustics for a music venue, teaching space, and of course meetings.

Grader on the Move: Give It Some Room!



We're now formally into the spring grading cycle. Please help by giving us room ... it's not helpful to have a car fly up on the grader (like the driver in the Tesla on Reserve Road the other day). This is, believe it or not, precision work

— especially the final pass. Interruptions make it tough to keep the grade right, and an interruption during that final pass often means the operator has to go back and start over. That wastes time and money.

Also on the subject of room: please keep obstructions and anything you care about at least a foot or so back from the edge of the roadway. Anything in or close to the ditchline will likely be damaged, if not removed. (And if there's debris remaining from the ice storms — tree parts, etc. — it would be really helpful to have that removed.)

Lastly, in the **Help Wanted** department: We're seeking someone to help with brush removal and trimming along portions of Moyaone roads. We need somebody with their own tools and equipment who can work independently and follow instructions to the letter. This is contract work for the Moyaone Association. Thoughts on Moyaone Roadsides and Looking at the Case of Poplar Hill

A shared sense of community, and of Home, following the recent traumatic body discovery, abandoned vehicle fires on our forested lanes, and other trespasses – is offered as a model for other sections of the Moyaone Reserve to also consider.

Many of us on the Poplar Hill Loop have redoubled our recurrent roadside TLC, at our own cost and elbow grease. May these actions of ours (and our helping hands, when trees block other sections of Moyaone Reserve roads), guided by Maryland DNR forestry practices, and NPS partner Scenic Easements (see partner article) offer inspiration beyond Poplar Hill's Loop.

The roads we had built in Moyaone Reserve's infancy are our properties' singular connection with the rest of the world. To keep the road surfaces and roadsides healthy, AND to keep the rest-of-world responsive to our rights of peace, property, and privacy, I, as an Overlook lifer and Poplar Loop Co-captain share an open letter to the rest of the Moyaone Reserve.

Poplar Loop Friends,

I hope you're all marching along into Spring with a sense of Home-pride and hope.

Among those focused on making our roads more definitively ours: The privacy we've earned by choosing our homes in a "No Outlet" forest nook can be helped through considering a range of actions. Gathered from my growing up here, and from a recent tour as Roads Chair, these include in random order (among those that you might add):

1) Keeping a handy roster of each Looper's phone number, and a calling-tree, to confirm status of each homesteader here, during weather events and otherwise.

2) Helping keep the Poplar Hill and Old Landing entrances kempt. Keeping clear the line of sight at Poplar and Old Marshall Hall Rd. (OMH) is an ongoing success, thanks to many of you readers!

a) swapping out old posts and rails, removing the tree bits, and

b) scrubbing/fixing the Old Landing sign

c) repainting the Poplar Hill sign (Candice Bigelow has some plans for that),

d) repairing/repainting the Ships Knee Drive sign, and de-vining (both) Overlook Drive signs.

3) Posting at the top of the OMH hill, at the Old Bill's Way/Red Dog Run intersection, a prominent sign that states: "No Outlet — No Trespassing Ahead/Private Property Enforced" or the equivalent. This is to decrease (at least among the driving population that cares) outsiders' vehicles on our private roads.

4) Placing, at least annually, the "Road Closed" signs (and posting this action in, say, the *Maryland Independent* newspaper), using "Road Closed/Private Property tripod signs at the Poplar/OMH and OMH/Old Landing

intersections. This can manifest by placing/posting (for 24 hours) such signs visible to drivers in a way to not create a safety hazard, as a visual, not physical barrier to ingress and egress.

5) Removing the large dead tree at the left side of Old Landing/OMH intersection, going downhill.

6) Further trimming back saplings damaged by the January storm. [Volunteers have safely and ably completed two intersections, and are proceeding, in sync with those whose road front it is, to again clear the balance of threatening limbs, trunks, and invasives along the roadsides.]

7) Dropping a timely heads-up to Stan@Fetter.net with a cc: to KentLHibben@gmail.com, for maintenance needs or tree clearings on the road's surfaces, with

a) the nearest mailbox number, and

b) if one or both lanes are not safely navigable.

8) Further engaging with USPP (Carl_Holmberg@NPS.gov, Officer Rannacher SDRannacher@co.pg.md.us from Prince George's County or Charles County Sheriff WorleyA@CCSO.us to keep knowledge of/responsiveness to our (private) stretches and Home-safety top of their mind.

9) Sharing with Officer Rannacher, and his Charles Co. colleagues, plates and descriptions of suspicious/reckless vehicles on our private roads, to identify trespassers/repeat offenders.

10) Encouraging the use of Poplar Leaf stickers for locals' vehicles.

11) Posting and placing cameras at intersections, following an okay from Loop landowners. Technology has improved, and the need has increased, for us to consider it for our Loop.

11) Identifying which vegetation to NOT remove (redbuds, cedars, etc.) and then, in coordination with the respective landowners with roads frontage, further proceeding with our successful volunteered Poplar Loop preemptive roadside management.

12) Working in sync with the Old Marshall Hall Rd.-based church, and its congregation, to keep an ongoing win-win neighborhood functioning, on topics of road safety and respect of private property (on our posted gravel roads)

Other Moyaone Reserve sections could consider these points independently, guided by the US DOJ Neighborhood Watch Manual, or the like, without impacting Moyaone Association budgets, as each section of Moyaone Reserve has unique residents' needs.

As we on the Poplar Loop and particularly Overlook Drive seek to regroup on our terms and reclaim Hope, we look forward to questions and to civil sorting-out of paths forward, respecting history, and furthering our role as successful neighbors and forest stewards.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That the Act of October 4, 1961 (75 Stat. 780), providing for the preservation and protection of certain lands in Prince Georges and Charles Counties, Maryland, as amended, is amended as follows:

(a) In section 2(b), amend the first sentence by striking out “drawing entitled ‘Piscataway Park,’ numbered NCR 69.714-18, and dated January 25, 1966,” and inserting in lieu thereof “drawing entitled ‘Piscataway Park,’ numbered PIS-P-90,000, and dated July 19, 1974”.

(b) In section 2(b), delete the words “The property herein described is more particularly depicted on the drawing numbered 1961-1, a copy of which is on file with the Secretary of the Interior.”

(c) In section 2(c), delete the first sentence and insert in lieu thereof the following: “Effective on the date of enactment of this Act, there is hereby vested in the United States all right, title and interest in, and the right to immediate possession of, all real property within the boundaries of the parcels designated A, B, C, and D, as shown on the drawing referenced in subsection 2(b). The United States will pay just compensation to the owners of any property taken pursuant to this subsection and the full faith and credit of the United States is hereby pledged to the payment of any judgment so entered against the United States. Payment shall be made by the Secretary of the Treasury from moneys available and appropriated from the Land and Water Conservation Fund, subject to the appropriation limitation contained in section 4 of this Act, upon certification to him by the Secretary of the Interior of the agreed negotiated value of such property, or the valuation of the property awarded by judgment, including interest at the rate of six (6) per centum per annum from the date of taking to the date of payment therefor. In the absence of a negotiated settlement or an action by the owner within one year after the date of enactment of this Act, the Secretary may initiate proceedings at any

time seeking a determination of just compensation in a court of competent jurisdiction. The Secretary shall allow for the orderly termination of all operations on real property acquired by the United States in parcels A, B, C, and D of this subsection, and for the removal of equipment, facilities, and personal property therefrom: *Provided*, That in no event shall the Secretary allow operations at the Marshall Hall Amusement Park to continue beyond January 1, 1980. The Secretary shall, on lands acquired for the purposes of this park, implement a development plan which will assure public access to, and public use and enjoyment of, such lands. To further the preservation objective of this Act, the Secretary of the Interior may accept donations of scenic easements in the land within the area designated as ‘Scenic Protection Area’ on the drawing referred to in subsection (b) of this section.”

(d) In section 4, delete “\$5,657,000” and insert “\$10,557,000”.

TITLE I—THE RAILROAD RETIREMENT ACT OF 1974

That the Railroad Retirement Act of 1937 is amended to read as follows:

“(i) any express company, sleeping-car company, and carrier by railroad, subject to part I of the Interstate Commerce Act;

“(ii) any company which is directly or indirectly owned or controlled by, or under common control with, one or more employers as defined in paragraph (i) of this subdivision, and which operates any equipment or facility or performs any service (except trucking service, casual service, and the casual operation of equipment or facilities) in connection with the transportation of passengers or property by railroad, or the receipt, delivery, elevation, transfer in transit, refrigeration or icing, storage, or handling of property transported by railroad;

“(iii) any receiver, trustee, or other individual or body, judicial or otherwise, when in the possession of the property or operating all or any part of the business of any employer as defined in paragraph (i) or (ii) of this subdivision;
